Decisions of admission (unconstitutionality in whole or in part, respectively with reservation of interpretation) = **1.041**, of which:

- preliminary review: **316** representing **52.93 %** of the total of **597** decisions rendered
- ex officio review of the initiatives for the revision of the Constitution: **4** – representing **36.36%** of the total of **11** decisions rendered
- review of the standing rules of the Parliament: **23** - representing **44.23%** of the total of **52** decisions rendered
- posterior review: **643** - representing **2.78%** of the total of **23.049** decisions rendered
- settlement of legal disputes of constitutional nature between public authorities: **21** representing **45.65%** of the total of **46** decisions rendered
- observance of the procedure for the election of the President of Romania: **13** – representing **3.05%** of the total of **426** decisions rendered
- other prerogatives as provided by the Court's organic law: **22** – representing **29.33%** of the total of **75** decisions rendered
